Notice is hereby given that a state general election will be held in Roseau County on Tuesday, November 2, 2010, for the purpose of electing candidates for the offices listed below. The filing period for these offices begins at 8:00 a.m. on Tuesday, May 18, 2010, and ends at 5:00 p.m. on Tuesday, June 1, 2010. **Note: Filing offices will be closed Monday, May 31, 2010, in observance of Memorial Day.** (*Minnesota Statutes, Section 204B.33*)

Candidates may file in person or by mail. Candidates who will be absent from the state during the filing period may arrange to file, in person, prior to departure.

The place of filing for federal and state offices is the Office of the Secretary of State, State Office Building, Room 180, 100 Rev. Dr. Martin Luther King Jr. Blvd., St. Paul, MN 55155-1299. (Candidates filing for state offices may file with the County Auditor of the county in which the candidate resides.)
