To Fill a Vacancy in the Office of Roseau County Commissioner of the Third District

Notice is Hereby Given, that pursuant to Minnesota Statutes, Section 375.101, a Special Primary Election will be held on Wednesday, the 3rd day of February, 2010, for the purpose of voting for and electing a Roseau County Commissioner in the Third District, to fill the vacancy of the term expiring January 3, 2011. The Third District Commissioner serves the following towns: Dieter, Enstrom, Grimstad, Jadis Unorganized, Malung, Norland/Spruce Valley Unorganized, Palmville, Ross, Spruce, Stafford, and Stokes.

Notice is Hereby Given, that since more than two candidates have filed for the Office of Second District Commissioner, a Special Primary Election will be held on Wednesday, the 3rd day of February, 2010. A Special Election will be held on Tuesday, the 23rd day of February, 2010.
